- WHERE:** Corpus Christi Gun Club – 2832 FM 763, Corpus Christi, TX. 78415  
*Please observe the posted speed limit on the property. 10 MPH STRICTLY ENFORCED*
- FORMAT:** (100) Target Clay shoot – 4-person teams. *Shells are NOT INCLUDED. Shot sizes are limited to 7 ½, 8 or 9.*
- TIME:** Check-in will open at 7:45 AM. ALL SHOOTERS MUST BE SIGNED IN NO LATER THAN 8:30 AM.  
Safety Meeting at 8:45 AM & Tournament starts at 9:00 AM.
- REGISTRATION:** Team \$1,000 or \$250 per shooter *(This event is limited to only 34 teams.)*  
You will be assigned to a team if you have a partial team or are single.
- STATION SPONSOR:** \$250 - The station's sponsor is allowed to display company banners, provide scoring services, and offer giveaways, drinks, snacks, and other amenities. Vehicles and alcohol are prohibited on the course, but tents are permitted.
